


# Three Sheriffs Named to Posts on National Level

MOBILE, Ala.—Three Florida Sheriffs were elected to important positions when the National Sheriffs Association held its annual convention here June 19-22.

Sarasota County Sheriff Ross E. Boyer was elevated to Fifth Vice President in the line of succession to the Presidency; Putnam County Sheriff E. W. (Walt) Pellicer was elected to the Board of Directors; and Marion County Sheriff Doug Willis was named State Director to represent his fellow Florida Sheriffs within the national organization.

Sheriff Boyer, in addition to his vice presidency, is serving as chairman of an Education-Scholarship Committee appointed by the President of the National Sheriffs Association to study law enforcement education and training programs throughout the nation.

A delegation of 10 Florida Sheriffs headed by St. John's County Sheriff L. O. Davis, President of the Florida Sheriffs Association, attended the national convention.



# Thugs, Slugs and A Heroine

BRONSON — There's an honorary deputy sheriff in Levy County and her name is Mrs. Ruby Hawthorne.

Sheriff Pat Hartley conferred the honor on her because of her courage in capturing one of the men who attempted to burglarize her grocery store.

She collided with the man as he was running from the store. He stumbled and fell and she told him not to get up or she would shoot him. A few minutes later her son, who had been unsuccessfully chasing another man involved in the crime, returned and the two took Billy Dixon, 39, into custody and called the sheriff.

The other two men involved, Leon McCumbers, 37, and Harley Jordon, 34, were caught, pleaded guilty and have been sentenced to 15 years. Dixon, who also pleaded guilty, had his sentence deferred until his attorney could be in court.

Jacksonville Attorney, Robert Zokvic, representing McCumbers and Jordon, had his day in court too when the presiding judge sentenced him to 5 days in the county jail for contempt of court. (He was late to court both days of the trial.)

But his troubles didn't end there. Upon being booked into jail by Sheriff Hartley, a routine inventory of his briefcase revealed a sack full of metal slugs, the type sometimes used in pay telephones. Sheriff Hartley immediately charged Zokvic with "possession of devices to avoid payment of pay station telephone calls."

# Records Shipshape

State Auditor Ernest Ellison submitted favorable reports to Gov. Haydon Burns after auditing the accounts and records of Osceola County Sheriff Bob Buckels and Leon County Sheriff Bill Joyce.

He stated all of Sheriff Buckels' collections of record were properly accounted for during the period from March 1, 1963, to July 31, 1965.

Remittances were accurately and promptly made; budgetary operations were generally well managed; and records were adequate and well kept, he added.

He made similar comments about the records and accounts of Sheriff Joyce for the period from March 1, 1965 to February 28, 1966.

# Paper Says Nix To State Police

KEY WEST — The Key West Sun agrees with the Florida Sheriffs Association that a State Police is "undesirable" in Florida.

"Law enforcement has traditionally been the responsibility of the sheriff and the police chief, who are answerable directly to the people," The Sun said in an editorial.

"Centralization of these functions on the state level could remove such public control of law enforcement."

The newspaper also praised efforts of the Florida Sheriffs Association and the Florida Police Chiefs Association to establish state-wide minimum standards for law enforcement.

This could produce "real improvement . . . in local law enforcement without giving up one iota of local control," the newspaper added.

Monroe County Sheriff Reace A. Thompson is a member of the Governor's Advisory Council which will recommend minimum standards for the entire state.



# Drowned Child Did Not Die in Vain

SEBRING-On a warm Sunday afternoon a decade ago Highlands County Sheriff Broward Coker lost a battle to save a drowning victim who had been on an outing with a Sunday School group. As the child's life slipped away the Sheriff vowed, "If it's possible I'm going to get some rescue equipment."

His vow brought into being a Sheriff's Rescue Unit that is now a widely

copied organization.

Race Week (The Famous Grand Prix of Endurance) is undoubtedly the busiest time for us," Sheriff Coker said, "but the Rescue Unit never gets a vacation. It's on perpetual stand-by. Some of the men are ready to lend a hand any time with just about any kind of rescue equipment you can imagine."

Some of the equipment-like helicopters and ocean-going boats-is privately owned by Rescue Unit members. More than \$50,000 worth of emergency equipment-diving gear, portable generators, resuscitators included-stands

ready at all times.

The 35 members of the Rescue Unit are well trained in all phases of rescue work. The Unit meets at least once each month and in addition the members study first aid, attend police training schools, are always at work to learn the newest methods of rescue and accident prevention.

Their training in traffic control is especialy helpful at Race time in help-

ing prevent accidents.

The Sheriff's Rescue Unit study in water safety is so extensive that for some years the Unit has been asked by the American Red Cross to furnish faculty for its water safety and lifesaving courses.

Besides raising money to buy rescue equipment, the Rescue Unit has sponsored fund raising projects for the Florida Sheriff's Boys Ranch. Sheriff Coker estimates that the Unit has raised about \$3,500 for the Ranch and about \$1,500 for other special projects around the county.

A favorite money-making project is a fish-fry, and many citizens who have eaten the fish, hush puppies and swamp cabbage at a Rescue Unit dinner are ready to declare the men outstanding

cooks.

Members of the Sheriff's Rescue Unit represent a wide variety of business and professional backgrounds, but all of them are widely known and respected citizens of the county. Members of the Unit select new members and annually choose officers. Membership limit is presently set at 35 (All members are active. This is a "doing" organization).

The weeks of Summer vacation are

busy ones for the Rescue Unit.

"We have equipment now, and we have trained personnel and all Summer long we have children-literally thousands of them. This is what the Rescue Unit is for; we carry tremendous responsibility here," the Sheriff said.

"Many people who live here all the time forget that when school is out the Girl Scout, Boy Scout, 4-H, YMCA and church camps we have all over this county fill up. They stay full until school starts again. Every camp has its trained leaders, but we have to be ready to give all the extra help possible if the need arises," he added.

The many fishing camps along the lakes and Kissimmee River present

potential emergencies too.

When asked about the unusual missions the Rescue Unit may have answered, the Sheriff replied quickly, "I can tell you that the happiest ones are the ones when we find missing people well and happy. This happens every once-in-a-while on Lake Istokpoga. It's so big across, but it's shallow and even a little storm makes it treacherous. More than once the Rescue Unit has gone down there to look for a missing fisherman, fearing the worst, then happily finding him safe on an island. Those are the happiest calls."






