TRIPS CANCELED BY SHERIFF'S OFFICERS

TAMPA – The arrest of six persons and seizure of 1,300 LSD tablets by Sheriff's narcotics detectives, canceled a lot of "trips."

Hillsborough County Sheriff Malcolm Beard said detectives confiscated a new variety of the hallucinogenic drug known as "pink zots." Value of the haul was put at between \$5,200 and \$10,400 depending on the selling price which varies from \$4 to \$8 a tab.

Five adults were charged with possession of LSD and marijuana and a 16-year-old girl was turned over to the juvenile court.

JACKSONVILLE OFFICERS USE COMPUTER INSTEAD OF MAP

JACKSONVILLE — The Duval County Sheriff's Department has claimed another first and it's called the "Street Index Inquiry System."

Sheriff Dale Carson explained the computer operated system can pinpoint an accident or call for help within seconds and eliminates the job of manually checking address files and maps.

When a citizen calls in a complaint or reports an accident the address is fed into the computer which almost instantly flashes on a television screen the beat number for the area in which the call originated, the wrecker zone, the "reporting area", and the nearest main intersection — all necessary to speed a patrol car to the caller's location.

The new system will be a big help Carson said, because "there are 4,805 streets with different names in the consolidated city and of this number, 158 names identify more than one street, causing much confusion."

Genung said the illegal drug was sniffed out by specially trained dogs in the San Francisco post office. The usual marijuana cigarettes, called "roaches," are usually much smaller and hand rolled in brownish paper, the Sheriff said. "If a person were standing next to you smoking one of these, the average person would not be able to detect they were marijuana unless he knew the smell," Genung said.

Two deputy sheriffs, less than 1,000 feet away, watched horrified as they tried in vain to reach him in time.

Deputy Sheriff Jack Cunningham said the youth weighed 195 pounds a year ago and when he died weighed only 140.

"He'd been popping narcotics," Cunningham said. "He was under the influence of whatever he was popping at the time."



Standing in front of Saunders Cottage, first building completed at the Florida Sheriffs Boys Ranch, State Rep. Ed Blackburn, Jr., of Tampa, recalls what the site looked like 13 years ago when the Ranch was just starting. He was Sheriff of Hillsborough County at that time, and also served as the first Executive Director of the Ranch. When 13th Anniversary ceremonies were held at the Ranch on October 4, 1970, he was the principal speaker.

It Was the 13th Anniversary Of the Boys Ranch, and We Went...



Ed Blackburn, Jr., loves to reminisce about the founding and early development of the Florida Sheriffs Boys Ranch, and no one is better qualified to do so - mostly because Ed has seen it all. He was there when a covey of Sheriffs wandered down to the banks of the Suwannee River in 1957 and said, in effect, "this is it - this is where we will build the Boys Ranch." He was the first Executive Director of the Ranch. He has been closely involved in its progress through the years, and he is currently a Boys Ranch Trustee Emeritus. There is another thing about Ed, he abhors formal, written speeches with a passion. Consequently, what he presented from the rostrum on October 4, during ceremonies celebrating the 13th anniversary of the Boys Ranch, was not so much an address as it was a casual stroll through the landmarks of his memory.

...Back Through

Mr. Chairman, Mr. Administrator, fellow Sheriffs, alumni of the Boys Ranch, staff members, Ranchers, friends all —

On this 13th Anniversary of the Florida Sheriffs Boys Ranch, I am especially grateful for the part I have been permitted to play throughout the years in its growth, its accomplishments, its hope for the future. Many of you have shared this wonderful experience, and therefore will perhaps enjoy recalling with me some of the events and accomplishments in the brief history of the Boys Ranch.

In 1957, in January, the Sheriffs had a convention in Key West, and it was decided to go into an honorary membership program. The program was really more successful than we thought it might be; and so, in Sarasota that year when we had another conference, in June, we found we had \$7000 left over after paying all our bills. That seemed like a lot of money. We met later at Sheriff Willis McCall's lodge, over in Lake County, and we decided to go into a Boys Ranch with the \$7000.

Somehow there weren't any of us had enough sense to know it couldn't be done. Nevertheless we put out a very profound announcement that a committee had been appointed to inspect sites for a Boys Ranch; and a little later the Sheriff of this county, the late Hugh Lewis, remembered that Tommy Musgrove had given 40 acres to the Elks Club for a youth project, and that Tommy also had 120 acres right next to it. Sheriff Lewis approached the Elks and Tommy and they very generously gave us the quarter of a mile along the Suwannee River.

Well, we realized if the idea was any good, 160 wasn't enough, and there were two adjoining farms, of about 560 acres that we could acquire for \$31,000 in cash. As you folks living in Live Oak know, you have two banks, and really, they are very generous banks, they don't inspect financial statements very closely, believe me. So we gave them \$5000 down; we borrowed \$26,000 from them, \$13,000

apiece. That's how we got the rest of the property. We realized it didn't cost any more to have big dreams than little cheap, "two-bit" dreams, and so we decided to go into operation with some 720 odd acres rather than 120.

Treasurer J. L. McMullen mentioned awhile ago that I was the first Executive Director of the Ranch. I might hasten to say it was a non-paying job, but the title was quite honorary at times. On the other hand, there were those of us who argued so much, and worked so hard throughout the years, it wasn't sometimes even honorary.

I know I lost a lot of money on the farm the first few years. Being Sheriff of Hillsborough County, urban area that it is, I wasn't the greatest farmer there ever was. I thought for one year I would try to make up the shortage of what we lost, by raising pigs. That, incidentally, was the last year we raised pigs.

In November, 1957, when I was asked to organize the Sheriffs and promote this Ranch, Pinellas County Sheriff Sid Saunders was president of the Sheriffs Association. We called a meeting in February, 1958, with Bay County Sheriff "Doc" Daffin as host, and we were going to start extensive planning of the Boys Ranch. At 3 p.m. on the day of the meeting I received a telephone call that Sheriff Saunders had died very unexpectedly. So, very sorrowfully, we went ahead with our meeting. The loss of his leadership was a blow to our efforts, but his death also drew attention to the project, and it gave the Ranch much valuable publicity. From that emphasis we got off to a running start.

The first cottage here was completed in January, 1959, and we dedicated it as the Sid Saunders Memorial Cottage. In February of that year — February 26, 1959, — the first four boys were admitted to this Boys Ranch, and now you can see, eleven years later, how far we have come. We've had a total of 250 boys through here that have been under the care and guidance of the Ranch. Over 60 have served in the armed ser-

vices of this country, including 15 or 20 in Viet Nam. I expect at least a half-dozen are there this afternoon, proudly defending our freedom, while we peacefully meet here.

After an uncertain beginning, we received help from all over the state, small contributions, big contributions. I never will forget one of the first ones we had along with a real plaintive letter. It was from a fellow who was serving a long sentence over in a prison camp north of Macclenny. The letter enclosed a \$10 U. S. money order. He said in effect he was raised out in Nebraska near Father Flanagan's Boys' Town, and if he had had the opportunity to go there he didn't feel he would have been serving time where he was that day.

Countless others helped us — like one afternoon when we had a dedication, Mr. C. E. Mendez, who passed away a couple of years back, came up to one of the trustees and made a voluntary contribution of \$30,000. This is only one instance of the love and devotion many people have given to the Ranch.

Our second cottage was a memorial to Sheriff F. L. McGehee, our third to Sheriff Hugh Lewis who had so much to do with building this Ranch. Col. Bob Pentland, one of the early trustees and a most successful accountant in Miami, gave the next in memory of his mother. The next, I believe, was the Merrill Cottage, dedicated to the founder of a famous Wall Street brokerage firm. Next, I think the Fred Conn Cottage was completed, and Mr. Conn passed away this year.

We have, of course, the Swick Cafetorium, in memory of Jim and Rena Swick of Copeland Sausage Company. They were lost in that fire, that tragic hotel fire, in Jacksonville several years ago. The wonderful gymnasium just completed by a friend down in Dade County who just passed away. Probably the finest laundry in Florida, in memory of a

man's wife. We have a really pretty swimming pool here, it's a "Pinellas County" swimming pool, and I'll tell you how that came about.

We had so many things donated to us, we didn't have a place to put them. I recognized we would have to do something, so we got together and sold a lot of Boys Ranch bumper stickers down in Hillsborough County at \$2 apiece and built a steel warehouse. I think we raised some \$13,000 to build it, gave it a very fine name, the Hillsborough County Vocational Training School.

I want to tell you about Pinellas County Sheriff Don Genung, one of the great promoters of all times. He had to leave early this morning to get back to his mother who is not well, but he also explained he wouldn't have to listen to my speech that way. Anyhow, when we built the Hillsborough County building I told Sheriff Genung if the poor people of my political party from Hillsborough could build this, it seemed the ultra rich people from that other political party — I won't call the name — could get together and raise \$35,000 to build a swimming pool. And so, Sheriff Genung and his friends, including those of that other party affiliation, quickly raised \$35,000, and so you see the Olympic size swimming pool out there today.

And so we are here today to dedicate the new 100,000-gallon Watersphere, given by an anonymous donor, and a radio ham shack. That's a giant step forward, for this radio voice can be heard literally around the world. And honestly, you can never tell where a seed will fall. This very chapel that we are in was the seed of one man's idea — our Memorial Fund. Donations to this fund financed the chapel we are in, and many other fine things.

Great memories belong to all of us who built this Ranch. I believe we have a net worth at the Ranch of well over two million dollars. Mortgages at the bank have long been paid.

But, rather than glory in the accomplishments of the past, it might be far more fitting that we dedicate ourselves to the challenges that the future affords.

And in thinking of some of the great challenges that have come to men throughout the years, I think perhaps the greatest was given some 2000 years ago, by the gentlest, kindest, sweetest man that ever lived as he sat on the side of a hill overlooking the shores of Galilee. And speaking to his friends he said this to them, Jesus said this to them: "Ye are the salt of the earth" then, the challenge. "But if the salt hath lost its savor, wherewith shall it be salted."

It took a long time for me to finally think this out. Webster's Dictionary defines savor as the quality of the thing that affects the taste and smell. It's the quality. Jesus was telling his disciples, "Ye are the salt of the earth." It's your job, it's your responsibility to spread this gospel of good — to salt the whole earth. However, if you lose that quality, if you lose that savor wherewith you are endowed, then the challenge is lost, in other words, it's no good.

As we meet here this afternoon, and as we think about the new project Florida's Sheriffs have taken on with the Girls Villa, (they are going to establish this same sort of institution down in south Florida) we can see a brand new challenge to help more youngsters and to help brighten their lives. And we will not be helping just these boys, the 125 now under the guidance of this Ranch, but 125 multiplied by 20 years, 40 years, 50 years — you take that same number and compound it, and add girls at the Villa too.

It would seem to me that the challenge lies with us here that we must dedicate ourselves to the potential that awaits all these youngsters.

And so, in closing, let me say this: let us not lose the savor, let us not lose the quality of that to which we dedicate ourselves; let us accept this challenge.


