LETTER FROM THE DIRECTOR



DEAR MEMBERS,

As the Office of Sheriff in Florida turns 200 years old this year, I am pleased to present the 2021 Florida Sheriffs Association Annual Report. This has been another challenging year for many, but we remain optimistic for better times ahead.

The commitment of Florida's sheriffs to continue innovating and researching processes and procedures is at an all-time high. They are working to maintain a safe environment for our citizens to live and for our visitors to enjoy, and the FSA has been right by their side to provide support. This report will give more details of the activity taking place, but I want to highlight some of our major achievements.

Crime is at a 50-year low! FSA is focused on consistently contributing to this accomplishment by providing access to up-to-date and free training for all sheriffs' offices through our Florida Sheriffs Training Institute (FSTI). This online learning platform provides access for all personnel to obtain valuable and relevant training that will help improve current skills, boost their professional development and help them learn about new trends and tactics. There are currently 8,357 members of sheriffs' offices registered in the system, and 153 courses are available through the FSTI with new courses being added regularly.

Since 2019 the FSA began offering grants for distributing life-saving bulletproof vests to deputies, providing shared assets to help respond to the needs of each community, and also providing scholarships to deputies to experience impactful training they might not otherwise be able to attend due to costs. Thanks to the tremendous support of our members, this year the FSA Board of Directors approved a financial increase to the grants allowing for more resources to be dispersed and utilized by sheriffs' offices. We are committed to protecting the safety of law enforcement and our citizens alike.

FSA membership is at an all-time high, and the growth of this collective group has influenced Florida's public safety positively! As of September 30, 2021, our honorary, law enforcement and business members totaled 103,131. Supporters are making their voices heard that they stand by those in

law enforcement. Remarkably, over 2,700 honorary members have been active for 25 years or more.

The sheriffs of Florida have been working hard with leaders surrounding impactful legislation that will make a difference locally and nationally. It is important to law enforcement that we continue to provide more resources to implement first-class training, supply equipment, and obtain professional accreditation standards. Most importantly, there is a continued focus to ensure that only the most qualified individuals will be allowed to wear the badge.

This past year has been a roller coaster of emotions. We were able to celebrate the Florida Sheriffs Academy graduation of 15 sheriffs, but we also grieved with loved ones as the names of 13 heroes were added to the FSA Memorial Wall. Throughout the entire year, no matter what type of emotions we were experiencing, everyone leaned on each other as one law enforcement family.

As you review the information in this report, you will see more about the programs and services we provide. This would not be possible without the continued support of our honorary, business and law enforcement members, as well as our corporate partners and sponsors. Thank you for your valuable support.



★ The FSA understands the importance of researching vital issues affecting the present and future state of the public safety in Florida and the nation. This year, we released our report on Repeat Drug Offenders in Prison: Not Your Low-Level. Non-Violent Offender.

8,201 REPEAT DRUG-RELATED OFFENDERS CURRENTLY INCARCERATED AT FDC.

- 298,783 prior charges resulted in 149,679 convictions.
- On average, each inmate had 36 prior criminal charges and 18 prior convictions.
- 86% of these inmates committed a prior forcible felony, a burglary or both, prior to their current state incarceration.

2,034 REPEAT DRUG TRAFFICKING OFFENDERS CURRENTLY INCARCERATED AT FDC.

- 38,369 prior charges resulted in 33,672 convictions.
- On average, each inmate had 19 prior criminal charges and 16 prior convictions.
- 89% of these inmates committed a prior forcible felony, a burglary or both, prior to their current state incarceration.

PRIORITIES

The FSA's priority bills, related to drones and the sexual offender registration loophole, passed the legislature, and were signed into law by the Governor. The drone's legislation created additional exceptions for law enforcement to use drones for things such as traffic management, collection of evidence at a crime scene or traffic crash, as well as other uses that will benefit all sheriffs in keeping their communities safe. Additionally, legislation that closed an unintended gap that had allowed sexual offenders to avoid registration as a sexual offender so long as they failed to pay their court-ordered fines passed and was signed into law by the Governor.



ADDITIONAL NOTEWORTHY LEGISLATION

The Florida Sheriffs Association also supported Governor DeSantis' priority legislation – the Combatting Public Disorder Act – which takes a robust approach to uphold the rule of law, stand with those serving in law enforcement, and enforce Florida's zero tolerance policy for violent and disorderly assemblies. The legislation successfully passed the legislature and was signed into law by the Governor at the Polk County Sheriff's Office on April 19, 2021.

COMMITTEES WE STAFF

FSA TASK FORCE

The first statewide task force operation, held in July 1989, was organized to address the growing crack cocaine problem. This year, the FSA task force completed two successful operations.



Operation Breaking Chains

focused on reducing human trafficking throughout the state and prosecuting those responsible for trafficking individuals. Twenty-nine victims were recovered, 31 traffickers were identified, and a total of 363 arrests took place.



Operation Loose Wire focused on reducing the number of livestock that are at large and that were being neglected, along with locating individuals who were illegally dumping waste material. The operation saw 388 animals returned to their owner and 252 citizens were contacted regarding agricultural land.

CAAP success story:

On July 1, 2021, the Escambia County Sheriff's Office responded to investigate the murder of Ladarius Clardy, an 18-year-old college quarterback at Kennesaw State University. While operating his vehicle after leaving a friend's house, someone shot over 50 gunshot rounds into his vehicle. The vehicle crashed into a wooded area and responding law enforcement found Clardy deceased and his 19-year-old passenger that had been shot and survived. The FSA worked with Escambia Sheriff Chip Simmons and the Gulf Coast Crimestoppers using the Criminal Apprehension Assistance Program to offer an additional \$5,000 in reward money. On September 30, the Escambia County Sheriff's Office made two arrests in connection to Clardy's murder. This case was solved because of multiple tips received.
