And because of the generosity of our members and supports, and good stewardship of our leaders, the FSA Board of Directors voted to make a \$600,000 contribution to the Florida Sheriffs Youth Ranches (FSYR). We were also able to continue our annual gifts of \$20,000 to COPS, the Florida Sheriffs Explorers Association and the Florida Deputy Sheriffs Association's (FDSA) Lend A Hand Fund in addition to our annual FDSA contribution of \$150,000.

EXPLORERS

At a week-long state conference in June, the explorers elect new board members for the next year and compete in crisis intervention, crime scene, high risk traffic stops training and a shooting competition.



FSA launched a true crime podcast in 2024. Florida has a population of 22 million residents and welcomed more than 137 million visitors last year. And although the overall crime rate has

dropped for an incredible 50 straight years, there are still more than 19,000 unsolved homicides in Florida dating back to 1965. The Cold Case Florida Podcast was created by the Florida Sheriffs Association to highlight some of those cases and offer the public an opportunity to help solve these crimes—bringing justice to the perpetrators and giving closure to the families. 




RESOURCES

FLORIDA SHERIFFS RESEARCH INSTITUTE



The FSA Research Institute partnered with the Florida Chamber of Commerce to publish the "Off-Ramps to Nowhere: How Soft on Crime Policies Make Communities Less Safe" report. The report highlighted Florida's sound policies established to combat crime and disorder. Although some states and prosecutors have decriminalized crime, legalized crime, defunded the police, and eliminated cash bail, Florida continues to adopt policies to combat crime and disorder. Unlike other states, Florida enacted a series of laws to deal with criminals committing repeated thefts and organized groups committing retail theft. The legislature

strengthened drug laws, and Florida Governor DeSantis and First Lady DeSantis launched Coordinated Opioid Recovery (CORE), which expanded every aspect of overdose response and substance use disorder treatment. Law enforcement funding was increased. bail laws were strengthened and juveniles who commit gun crimes are now held in secure detention until they appear before a judge. Unlike reform policies that have led to increased crime, billions of dollars lost to rampant retail crime, and open-air drug markets, Florida's elected leaders have taken positive steps to ensure economic prosperity and community stability.

FLORIDA SHERIFFS ACCREDITATION ASSISTANCE PROGRAM

Five agencies were awarded their first law enforcement accreditation by the Commission for Florida Law Enforcement Accreditation (CFA):

- Dixie County
- DeSoto County
- Jackson County
- Levy County
- Okeechobee County

The Levels recognition program was implemented to introduce the accreditation process to the agency and reward progress. Three levels of recognition based on the CFA Law Enforcement standards were established. Fifteen agencies received a Level 1 award and several agencies received Level 2 and Level 3 awards.

GOVERNMENT AFFAIRS

PRIORITIES

The FSA's priority bills were passed by the legislature and were signed into law by Governor DeSantis.

- JUVENILE GUN CRIME: The FSA's priority bill related to juvenile gun crime was developed with multiple stakeholders, including Florida Attorney General Ashley Moody and the Florida Department of Juvenile Justice (DJJ), to close gaps in the current law to ensure juveniles are held accountable when they commit serious gun crimes. The bill will help address the increasing violent juvenile gun crime across the state.
- Florida Sheriffs Association strongly supported legislation that allows all Florida Retirement System (FRS) Pension Plan members, including sworn law enforcement and correctional officers, to return to FRS employment after six calendar months of becoming a pension plan retiree without restrictions or interruption of pension plan benefits. Previous law made retirees wait more than a year to return to work at an FRS employer. This change in law will greatly assist sheriffs with rehiring experienced personnel faster and managing staffing levels.
- while they are at school, continues to remain a top legislative priority for sheriffs. The new school safety legislation amended state law to establish new perimeter and door safety requirements that school districts and charter school governing boards must comply with. These requirements include keeping routes of ingress and egress securely closed and locked when students are on campus. Each school district is now required to develop a progressive discipline policy for instructional and administrative personal who knowingly violate school safety requirements.
- RETAIL THEFT/COMBATING PORCH PIRATES: This bill cracks down on organized retail theft and porch piracy in Florida by increasing the criminal penalties associated with organized retail theft and lowering the threshold value for stealing packages

from a person's home. It makes it a third-degree felony for an individual who joins five or more people in retail theft, a second-degree felony if the same group encourages others to join in through social media, and a first-degree felony for any repeat offenders who have already been convicted of the same crime within a one-year time period. Under the bill, the punishment for criminals who steal delivery packages from private properties will be a felony if the package is valued at or above \$40. Currently, the law enforces punishments of a felony if the product is valued at \$100 or above.



COMMITTEES WE STAFF

TASK FORCE

HURRICANE DEBBY: The storm made landfall on August 5, 2024. Taylor, Lafayette, Madison, Dixie, Suwannee and Levy counties were impacted. The Task Force deployed and responded to 13 missions with 132 personnel.

HURRICANE HELENE: This Category 4 hurricane made landfall on September 26, 2024. The hurricane followed the same path of Hurricane Debby and Hurricane Idalia in 2023. FSA deployed over 260 personnel into the impacted area for security and search & rescue missions. This event affected several counties along the Gulf corridor resulting in numerous deaths in Pinellas County.





CRIMINAL APPREHENSION ASSISTANCE PROGRAM

- ★ FSA offered rewards for 10 UNSOLVED **CASES** throughout Florida.
- ★ Committed \$50,000 in potential reward funds towards tips to assist with solving crimes.
- ★ Three of these cases were solved and \$15,000 was paid out to tipsters. These cases were a homicide in Marion County, a child sex abuse case in Osceola County and a homicide in Miami-Dade County.
